### 1% IQMS

Die SAOU het navrae ontvang vanaf lede wat nie die terugbetaling van die 1% IQMS op 30 November 2015 ontvang het nie.

- Opvoeders sal **NIE** vir die 1% IQMS kwalifiseer nie op grond van die onderstaande:
  - Indien 'n opvoeder **nuut aangestel** is na 1 Januarie 2013 (onthou dat nuwe toetreders eers vir 24 maande in diens moet wees en geëvalueer moet wees voordat hulle kwalifiseer: PSCBC Res 1/2012).
  - Indien 'n opvoeder **bevorder** is tussen 1 Julie 2014 en 30 Junie 2015. (Kollektiewe Ooreenkoms 5 van 2006 dui aan dat 'n persoon op dieselfde salarisposisie/kerf vir die betrokke tydperk moet wees om te kwalifiseer).
  - Indien 'n opvoeder vir 'n lang tydperk **afwesig** was as gevolg van siekteverlof (bv PILIR) en gevolglik nie geëvalueer kon word nie.
- LET WEL:** Indien u gekwalifiseer het en nie die 1% IQMS ontvang het nie, kan dit wees as gevolg van die volgende:
  - Maak asb seker dat daar nie 'n onderbreking van diens was nie.
  - Indien 'n opvoeder vanaf 'n ander provinsie na Noordwes oorgeplaas is gedurende die tydperk 1 Januarie 2014 tot 30 Junie 2015. Maak seker dat u IQMS evaluering en punte wel oorgeplaas is na Noordwes.
  - Indien 'n opvoeder op 'n kontrakaanstelling was, die kontrak verstryk het, maar die opvoeder die volgende dag heraangestel is. (Op PERSAL kan daar moontlik 'n "beëindiging van diens" aangedui word omdat die kontrak verstryk het).

Indien u die IQMS aanpassing reeds ontvang het, is u salarisposisie alreeds met 'n kerf aangepas (1%). Die nuwe kerf sal op die salarisadviesstrokie van Desember

### 1% IQMS

The SAOU received enquiries from members who did not receive the 1% IQMS backpay on 30 November 2015.

- Educators will **NOT** qualify for the 1% IQMS in the following cases:
  - If an educator was **newly appointed** after 1 January 2013 (remember that new entrants can only qualify after 24 months in service and after having been evaluated: PSCBC Res 1/2012).
  - If an educator was **promoted** between 1 July 2014 and 30 June 2015. (Collective Agreement 5 of 2006 clearly indicates that a person had to be on the same salary position/notch during the period to qualify).
  - If an educator was **absent** from work for a long period (for example PILIR) and subsequently could not be evaluated.
- NOTE:** If you qualified, but did not receive the 1% IQMS, it could be due to the following:
  - Please ensure that there was no break in service.
  - If you were transferred from another province to North West during the period 1 January 2014 to 30 June 2015. Please ensure that your IQMS evaluation and scores were also transferred to North West.
  - If you were on contract and your contract expired, but you were re-appointed the next day (there could possibly be a "termination of service" reflecting on PERSAL because your contract expired).

### 3. TAKE NOTE

If you received the IQMS adjustment, your salary position has already been adjusted by 1 notch (1%). This new notch will reflect on your December 2015 salary advice. The backpay you received is the difference between the 2 notches, for the period July – November, minus tax.

If you have studied the above carefully, and you are still certain that you qualified for the payment of IQMS, but did not receive it, you are requested to complete the attached form and return it to **Riette Schoeman** at [vvvnw@saou.co.za](mailto:vvvnw@saou.co.za) or **086 616 8058**.
