Die SAOU is weer eens oorval deur navrae van bekommerde lede n.a.v. vals berigte op sosiale media. Volgens gerugte gaan die Public Investment Corporation (CIP), wat verantwoordelik is vir die bestuur van die Regeringswerknemerspensioenfondse se fondse, betrokke raak by die herfinansiering van die Suid-Afrikaanse Lugdiens (SAL).

The SAOU has been inundated with enquiries by concerned members as a result of false reports on social media. According to the rumours a struggling South African Airways (SAA) could possibly be funded by the Public Investment Corporation (CIP), which manages the GEPF's funds.

As Afrika se grootste pensioenfondse, het die Regeringswerknemerspensioenfondse meer as 1.2 miljoen aktiewe lede, met meer as 400 000 pensionarisse en begunstigdes, asook bates ten waarde van meer as R1.6 trillion.

Being Africa's largest pension fund, the Government Employees Pension Fund (GEPF) has more than 1.2 million active members, in excess of 400 000 pensioners and beneficiaries and assets worth more than R1.6 trillion.

Die bogenoemde wetgewing bepaal nie alleenlik hoe die Regeringswerknemers-pensioenfonds fondse moet insamel van bydraende lede nie, maar ook hoe dít belê en voordele aan kwalifiserende persone uitbetaal moet word.</p> <p>Tans is die Fonds een van min, baie groot vasgestelde voordeelfondse in die wêreld wat 100% befonds is.</p>	<p>As GEPF is a defined benefit fund, the Fund has to adhere to strict regulations governing its financial liability to members and pensioners.</p> <p>The GEPF has to follow the rules set out in the Government Employees Pension (GEP) Law. Not only does this law and its rules explain how the GEPF must collect money from contributing members but also how the money must be invested and benefits paid out to those eligible for benefits.</p> <p>GEPF is currently only of very few large defined benefit pension funds in the world which funded 100%.</p>

<p>'n Vasgestelde voordeelfonds is 'n fonds waar die voordele in terme van reëls definieër word. By die Regeringswerknemerspensioenfonds word die voordele oor die algemeen gewaarborg en is nie afhanklik van die belegginsopbrengs van die fonds of die bydrae van die lid- en werkgewer nie.</p>	<p>A defined benefit fund is a fund where the benefits are defined in terms of the rules. In GEPF, benefits are generally guaranteed and are not dependent on the investment return of the fund or on the level of member and employer contributions.</p>
<p>Onthou dat die Regeringswerknemers-pensioenfonds nie 'n voorsorgfonds is nie, maar 'n pensioenfonds. U pensioenvoordeel is veilig aangesien die hoofdoel van die Fonds is om die belange van die lede en pensionarisse te beskerm deur effektiewe administrasie en omsigtige beleggings.</p>	<p>Remember that GEPF is not a provident fund; it is a pension fund. Your pension benefit is secure as the primary role of the GEPF is protect the interest of its members and pensioners by safeguarding their retirement benefits through proper administration and prudent investment.</p>
