VOTING PROCEDURE: PEC MEMBERS *CIRCUIT 3*: 2016

You as the SAOU Shop Steward are kindly requested to manage the voting process of ***CIRCUIT 3*** at your school / institution. Make enough copies of the ballot-papers so that every SAOU member will receive one.

If the Shop Steward is a nominated candidate, we request that another SAOU member on the staff, who is not a candidate, acts as polling-officer.

Please follow the following instructions:

1. Please arrange a suitable time (e.g. during break) for the election.
2. Provide every SAOU member with a ballot-paper.
3. Draw the attention to the fact that they have **3 (three) votes each. (3 candidates have to be elected).**
4. When the SAOU members have voted, you must collect the ballot-papers.
5. **Note:** A second colleague count the votes with you and let the person sign the document as witness.
6. Count the number of votes for the respective candidates and write the number opposite every candidate's name on the **Result document.**
7. After calculation votes, the Result document must immediately be forwarded to the SAOU Eastern Cape Executive Centre - **on or before 23 September 2016.**

9. Also Complete the **Statement** that the process has been managed correctly.
