AANSOEK AS MERKERS: BEHEERLIGGAAMPOSTE

Onderwysers wat aansoek doen om as merkers aangestel te word tydens die Nasionale Senior Sertifikaat moet asseblief let op die volgende:

- 1) Onderwysers wat deur Beheerliggame aangestel is, beskik nie oor 'n Persalnommer nie. Daar word jaarliks tydelike Persalnommers aan hulle toegeken wat net vir drie maande geldig is en dan weer verval.
- 2) Die persalnommer wat u in 2016 ontvang het moet nie weer gebruik word nie, aangesien die Persalstelsel in Bhisho nie weer daardie nommers herken nie, en dit veroorsaak laat betalings of geen betalings nadat die merksessie voltooi is.
- 3) Beheerliggaam Ondewysers wat wel Persalnommers het omdat hulle deur die staat vergoed word vir koshuisdiens, moet asseblief nie daardie nommers op hulle aansoekvorms gebruik nie. Sodanige nommer word toegeken slegs vir Koshuisdiens en daardie nommer verskil van 'n Onderwyser se Persal wat deur die staat in diens geneem is.
- 4) Indien daardie nommer op die aansoek ingevul word, herken die stelsel dit nie as 'n gekwalifiseerde onderwyser nie, en gee dit aanleiding tot geen betaling vir merkwerk gedoen tydens die Nasionale Senior Sertifikaat.

APPLICATION AS MARKERS: SGB APPOINTED EDUCATORS

Educators appointed by SGB's who applied to mark in the 2017 NSC Examination should take note of the following:

- 1) SGB Educators do not have a Persal number. A Persal number is issued annually during the marking session and is only valid for three months before it expires.
- 2) The number received in 2016 should not be used again due to the fact that the Persal system in Bhisho will not recognize that specific number again. The implication will be late payment or no payment after NSC marking is concluded.
- 3) SGB Educators, who do have a Persal number due to the fact that they are remunerated by the DoE for Hostel services rendered, should not use this Persal number when applying to mark during the NSC examination. This specific Persal differs from those of educators in service of the DoE and will not be recognized by the system as that of a qualified educator.
- 4) If SGB Educators use their 2016 Persal number on the application forms, the system will not recognize the person as a qualified educator. The result will be no payment for any marking been done during the examination.
