



### **Postevoorsiening 2017**

Tydens 'n vergadering op 23 Junie 2017 van die Provinsiale Uitvoerende Raad van die SAOU: Oos-Kaap is die volgende besluite ten opsigte van Postevoorsiening 2017 geneem:

1. In gevalle waar die Skoolhoof geen antwoord op die appélaansoek wat ingedien is, ontvang het nie, word aanbeveel dat opvoeders wat botallig verklaar is, nie skuif van hulle huidige skool af nie totdat die Departement uitsluitel gee oor die appélaansoek.
2. Waar antwoord op appélaansoeke wel deur die Skoolhoof ontvang is, moet die proses soos uiteengesit in Kollektiewe Ooreenkoms 4 van 2016 streng nagekom word.
  - 2.1. Die Skoolhoof moet weer vergaderings met die personeel hou, notules neem en volgens die reëls van Kollektiewe Ooreenkoms 4 van 2016 botallige poste identifiseer.
  - 2.2. Die Departement moet 'n lys van die nuutste vakatures beskikbaar stel aan die opvoeders wat dan botallig verklaar is nadat appélaansoeke oorweeg is.
  - 2.3. Antwoorde op appélaansoeke moet deur die Departement aan skoolhoofde gestuur word en nie direk aan botallige opvoeders nie.
3. Indien opvoeders wat botallig verklaar is wel na 'n ander skool wil skuif, het hierdie opvoeders die reg om dit te doen.

### **Post Provisioning 2017**

At a meeting held on 23 June 2017, of the Provincial Executive Council SAOU Eastern Cape, the following decisions were taken regarding the 2017 Post Establishment:

1. In cases where the Principal has not received an answer to the appeal, it is recommended that educators who have been declared in excess do not move from their current school until the Department gives an opinion on the appeal application.
2. Where the answer to appeals has been received by the Principal, the process as set out in Collective Agreement 4 of 2016 must be strictly adhered to.
  - 2.1. The Principal must again hold meetings with the staff, take minutes and identify additional posts according to the Collective Agreement 4 of 2016.
  - 2.2. The Department must make a list of the latest vacancies available to the educators who have been declared in excess after appeals have been considered.
  - 2.3. Answers to appeals must be sent to the principals by the Department and not directly to educators in excess.
3. If educators who have been declared in excess are willing to move to another school, these educators have the right to do so.

### **Postevoorsiening 2018**

Die SAOU is tans betrokke by die Raad van Arbeidsverhoudinge Onderwys met onderhandelings ten opsigte van die postevoorsiening van 2018. Verskeie aspekte wat tot onsekerheid en onstabiliteit in skole gelei het, sal aangespreek word, byvoorbeeld graad R-poste, remediërende poste, IIAL, tegniese en spesiale skole, die werkwyse en interpretasie van die Kollektiewe Ooreenkoms 4 van 2016.

### **Post Provisioning 2018**

The SAOU is currently involved in negotiations in the Council of Labour Relations Education on the post provision of 2018. Various issues that led to uncertainty and instability in schools will be addressed, for example, Grade R posts, remedial posts, IIAL, technical and special schools, the procedures and interpretation of Collective Agreement 4 of 2016.

### **Departementele Werkswinkels**
