UPDATE OF PERSONAL INFORMATION

We would like to remind you to immediately submit any change in your personal information to the SAOU as well as the Department of Education. I would refer you to the PAM Document, Chapter I point 1.6.1 and point 1.7.1. It reads as follows:
"1.6.1. An educator must notify the department of education of his/her residential address and telephone number, if any, and of any change thereof"
"1.7.1. An educator must, within 30 days after getting married or after his/her marital status has changed, submit a certified copy of the marriage certificate, decree of divorce or death certificate, as the case may be, to the department of education"
