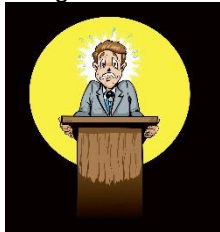

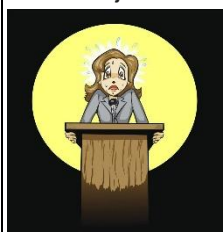

Let asseblief veral op na die volgende:

1. Korrektheid en verandering van naam, (veral waar 'n dame getrou het), selnommer en E-posadres.
2. Statusverandering, m.a.w. indien 'n lid 'n Beheerliggaamaanstelling gehad het en nou 'n permanente departementele pos beklee, of andersom.
3. Indien 'n lid in 'n tydelike aanstelling was en nou permanent departementeel aangestel is.

Members' information

Communication with our members is of utter importance. Therefore, we require that SAOU members update their personal information.

Please take note of the following:

1. Correctness and change of name, surname (in the case of marriage), cell number and Email address.
2. Change of status – Governing body appointment to permanent appointment, or vice versa.
3. If a member was in a temporary post and is now appointed in a permanent departmental post.

4. Indien 'n onderwyser, wat reeds lid is van die SAOU, van 'n ander provinsie skuif, moet daar ook 'n nuwe aansoekvorm om lidmaatskap voltooi word. Na voltooiing kan die vorm na die Kantoor deurgestuur word (saoukzn@saou.co.za).
5. Lede moet asseblief hulle salarisstrookies nagaan. Indien daar 'n tweede aftrekking van R96,95 vir PSCBC (agency) verskyn, beteken dit dat u nie by 'n vakbond geregistreer is nie. Indien u by die SAOU aansluit, sal die aftrekking deur die SAOU aftrekking van R95,71 vervang word.

4. If an existing SAOU member relocates from another province, a new SAOU membership application form must be completed. Completed forms can be sent back to the Office (saoukzn@saou.co.za).
5. Members must regularly check their salary slips. If there is a second PSCBC (agency) deduction of R96,95, it means that you are not registered with any union. If you join the SAOU, the second PSCBC (agency) deduction will be replaced by a SAOU deduction of R95,71.
