GDE HOUSING ALLOWANCE

The SAOU (Gauteng) would like to empower members concerning the Housing Allowance (Home owners and Tenants) so that members do not suffer financial losses due to incomplete applications which result in a delay of the implementation of the Housing Allowance by the GDE.

The SAOU (Gauteng) encourages members to use the checklist to ensure that all the necessary and relevant documentation is handed in. [Click here](#) to **download the checklist**.

Members are also advised to record the day and date on which the application was sent to the GDE. The date on which the GDE received the COMPLETE application, must serve as the basis for determining the date of implementation.

Members must also note that it is their personal responsibility to inform the employer of any change concerning home ownership/change in rental agreement and/or any change in personal particulars especially regarding home addresses.

TENANTS must take note of the following:

- All tenants **MUST** be registered at the GEHS (Government Employees Housing Scheme). It is **very important** to note that a printout of the GEHS enrolment confirmation must be attached to all documentation.)

- Tenants: Appointed before 1 July 2015 : R900 & R498.35 in saving facility.
New employees appointed AFTER 27 May 2015: NO PAYMENT on their salary slip – R1398.35 in saving

Discrimination based on marital status has been abolished, i.e. both spouses will henceforth qualify for the housing allowance. 2. The implementation will be as follows: <ol style="list-style-type: none"> a. Salary levels 1 – 5 (less than R204 612 pa) qualify wef 1 September 2018; and b. Salary levels 6 – 12 (R204 612 pa and more) qualify wef 1 September <u>2019</u>. c. Note: All educators thus qualify wef <u>1 September 2019</u>.

3. Die behuisingstoelaag beloop tans R1398.35 pm en word jaarliks aangepas met die VPI van die voorafgaande 12 maande.

3. The housing allowance currently amounts to R1398.35 pm and will be adjusted annually in terms of the CPI of the precedings 12 months.
