SALARISSE VAN LEDE IN TYDELIKE DEPARTEMENTELE POSTE SALARIES OF MEMBERS IN TEMPORARY DEPARTMENTAL POSTS

Die SAOU (Noordwes) ontvang baie navrae van tydelike personeel wat salaris ontvang, maar wat heelwat minder is as wat in ander maande ontvang was.

Dit gebeur wanneer daar supplementêre betalings gelaai is en nie as deel van die normale salarisbetaling gedoen is nie. Supplementêre betalings word belas deur SARS met tot 30%, afhangende van u inkomstegroep.

Daar is twee maniere waarop hierdie aftrekking reggestel kan word:

1. Daar word elke 3 maande 'n outomatiese rekonsiliasie op die stelsel gedoen. Daar behoort dan vir 'n maand of twee heelwat minder belasting as normaalweg verhaal te word.
2. Indien bogenoemde nie gebeur nie, sal dit reggestel word wanneer u opgawe by SARS ingehandig word.

Daar is steeds heelwat tydelike opvoeders wat nog nie salaris ontvang het nie, ten spyte van die skrywe wat Dr Molale op 1 Februarie 2017 na skole gestuur het. Hy het die departement daartoe verbind dat alle uitstaande salarisse teen 7 Februarie 2017 sal betaal wees.

The SAOU (North West) receives many queries from temporary employees regarding salaries paid out which are less than previous months.

This happens when the salary is paid as a supplementary payment and is not part of the normal salary run. SARS taxes supplementary payments at up to 30% depending on the tax bracket of the employee.

There are two ways in which this can be corrected:

1. Every three months the system does an automatic reconciliation. After this, for a month or two, an employee would then have a lower tax deduction than normal.
2. If the problem is not corrected in this way, it will be corrected when you hand in your tax return at SARS.

There are still many temporary educators who have not received their salaries regardless of the notice sent to schools by Dr Molale on 1 February 2017. He indicated that all outstanding salaries would be paid by 7 February 2017.

It seems that this wasn't realistic. Staff at Human Resources is working overtime to try and finalise
