



### LDvO STAKING / LDoE STRIKE



Die amptenare van die LDvO is al vir meer as 'n week gewikkel in 'n industriële aksie. Aanvanklik was dit net gekonsentreer rondom die HR (Human Resource) afdeling in Polokwane, maar dit het weldra uitgebrei na ander kantore, ook na distrikkantore. Nieteenstaande die feit dat die LUR 'n interdik teen die stakende amptenare bekom het, duur die aksie voort. Die stakings het die volgende rippel effek: / *The officials of the LDoE have been on strike for more than a week. Originally it was concentrated around the HR offices in Polokwane, but it has later been extended to all other departmental offices, also district offices. Even though the MEC has obtained an interdict against the striking workers, the strike continues. The strike has the following ripple effect:*

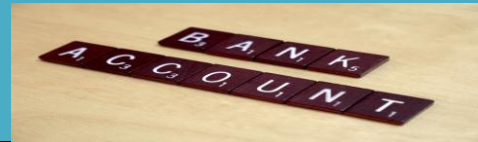


## ALGEMENE SALARISVERHOOGING / GENERAL SALARY ADJUSTMENT

Die Staat het die 2017 algemene aanpassing verklaar op 7.3% (VPI + 1%) vir alle diensdoenende staatsdiensamptenare en die GEPF (Government Employee Pension Fund) het 'n verhoging van 6.6% vir alle staatsdiens pensioenarisse afgekondig. Beide met ingang van 1 April 2017.

*The State has announced the 2017 general adjustment rate at 7.3% for all state employees (CPI + 1%) and the GEPF (Government employee Pension Fund) announced a 6.6 % increase to their members. Both increases will be implemented from 1 April 2017.*

## SALARISSE WAT LAAT BETAAL HET / SALARIES PAID LATE



Verskeie aanmeldings van onbetaalde salarisse is ontvang op 22 Maart 2017.
