IRP5's

Daar is in die afgelope week verskeie navrae ontvang rakende die 2016 – 2017 IRP5 sertifikate wat uitgereik is. Daar is ooglopende foute begaan met die sertifikate wat die opvoeders bereik het, die inligting het verskil van dit wat reflekteer op hulle profiele by SARS. Die LDvO het gelukkig die probleem opgetel en dit reggestel. Diegene wat weersprekende sertifikate ontvang het, het intussen die korrekte IRP5s ontvang van die werkgever. Lede word gevra om seker te maak dat hulle sertifikate nie steeds foute bevat wanneer hulle belasting opgawes indien nie.

We have received several enquiries regarding the 2016 - 2017 IRP5 certificates that were issued to educators. Visible mistakes were noted on the certificates that reached educators; information didn't correspond with what was captured against their profiles at SARS. Luckily, the LDoE picked up on the mistake and corrected it. Those who had contradictory certificates did receive the correct version from the employer soon afterwards. Members are requested to ensure that their certificates are without discrepancies when they submit their tax returns.
