Indien u onseker is in watter SAOU-kring u is, sien die lys aan die einde van die nuusbrief.3. Uit elke kring moet 3 kringorganiseerders verkies word en die verkose lede vorm dan deel van die Provinsiale Uitvoerende Raad (PUR).4. Wanneer lede nominasies maak, moet die vereistes van die Grondwet in gedagte gehou word. (<i>Daarvolgens word verlang dat jonger persone, mans en dames van alle rasse, asook gestremdes verteenwoordig word.</i>)5. Elke lid mag 'n maksimum van drie lede uit die Kring as Kringorganiseerders nomineer. Indien slegs drie persone uit 'n bepaalde kring genomineer word, sal hulle as wettig verkose beskou word.<ol style="list-style-type: none">5.1. 'n Aparte nominasievorm moet vir elke genomineerde voltooi word.5.2. Die genomineerde moet sy/haar toestemming verleen. The SAOU (<i>Limpopo</i>) is divided into 3 circuits for organizational reasons.2. Please consult the list at the end of the newsletter if you are uncertain about the circuit you are situated in.3. Within each circuit, 3 circuit organizers should be elected and these elected members form part of the Provincial Executive Council (PEC).4. When members nominate a person, the requirements of the Constitution must be kept in mind. (<i>According to the Constitution younger members, men and women of all races and people with disabilities should be represented.</i>)5. Each member may nominate a maximum of three members in their circuit as Circuit organisers. If only three people from a particular circuit are nominated, they will legally be considered as the elected members.<ol style="list-style-type: none">5.1. A separate nomination form must be completed for each nominee.5.2. The nominee must give his / her consent. An acceptance form will be sent to you and must be provided to each nominee. Information therein will also serve as a CV.5.3. Members will be informed on 19 September 2019 through Elections Newsletter 2 on the nomination- and election processes and the deadlines involved in both processes.6.
