**PUR VERKIESING 2019**

**STEMPROSEDURE :**

Lede se aandag word verwys na Verkiesingsnuusbrief 1 van 2019. (In vermelde nuusbrief is lede ingelig dat Limpopo om organisatoriese redes in 3 kringe opgedeel word. Die vereiste was dat daar ten minste 3 nominasies vir elke kring uitgebring moet word.

Teen die spertyd van 4 Oktober 2019 om 12:00 vm (soos genoem in Limpopo Nuusbrief 29 van 2019) is daar slegs 3 nominasies per kring ontvang.

Die nominasie proses is nagegaan deur die eksterne ouditeure en die proses en nominasies as geldig in terme van die vereistes van die Grondwet verklaar.

Dit is dus nie nodig dat daar enige stemproses gevolg hoef te word in enige een van die 3 kringe in Limpopo nie. Die 3 genomineerde kandidate sal outomaties dien op die PUR en verteenwoordig daardie spesifieke kring. Hulle besonderhede is as volg:

**PEC ELECTION 2019**

**VOTINGPROCEDURE FOR :**

Members' attention is referred to Election Newsletter 1 of 2019. In this newsletter members were informed that Limpopo is divided into 3 circuits for organizational purposes. The requirement was for at least 3 nominations to be submitted for each circuit.

By the deadline of October 4, 2019 at 12:00 noon (as mentioned in Limpopo Newsletter 29 of 2019), only 3 nominations per circuit were submitted.

The nomination process was reviewed by the external auditors and the process and nominations declared valid in terms of the requirements of the Constitution.

There is no need for any voting to take place in any of the 3 circuits in Limpopo. The 3 nominated candidates will automatically serve on the PEC and represent that particular circuit. Their details are as follows:
