Opleiding – Remediërende Lees
Training – Remedial Reading

Op **9 en 10 April** gaan SAOU (Limpopo), in samewerking met Stimulus Maksima, 'n omvattende opleiding aanbied rakende **remediërende lees**. Statistieke toon al 'n geruime tyd dat die leerders in ons skole nie kan lees nie, maak nie saak of hulle in die hoër – of laerskool is nie.

*On 9 and 10 April, SAOU (Limpopo), in collaboration with Stimulus Maksima, will be offering comprehensive training on **remedial reading**. For some time, statistics have shown that learners in our schools cannot read, no matter whether they are in high - or primary school.*

Die Provinsiale Uitvoerende Raad (PUR) van SAOU (Limpopo) het die besluit goedgekeur

The Provincial Executive Council (PEC) of SAOU (Limpopo) has approved the decision

dat alle opleiding van tussen 1 – 3 uur gesubsidieer sal word. Dit bring mee dat die kostes van provinsiale opleidings as volg bepaal word:
 Lede – R50
 Studente (reeds by SAOU geregistreer) – gratis
 Nie-lede – bedrag word per geleentheid bepaal.

*that all training of between 1 and 3 hours will be subsidized. This means that the costs of provincial training are as follows:
 Members - R50
 Students (already registered with SAOU) - free of charge
 Non-member - amount is determined per occasion.*

Koshuistoelae - hofsaak
Hostel Allowance – court case

In 2018 het SAOU (Limpopo) 'n tweede hofsaak rakende die nie-betaling van koshuistoelae aanhangig gemaak. Dit het alle lede ingesluit wat geen, of slegs gedeeltelike betalings ontvang het tussen 2012 en 2017. Die oorspronklike aansoek het 32 SAOU lede gelys wat aangedui en bewys het dat hulle sodanig benadeel is. Deur die loop van 2018 het verskeie van hierdie gelyste lede betalings ontvang voordat die saak in die Arbeidshof gedien het. Ongelukkig is daar nog 8 lede wat nie vergoed is nie, en die aansoek is derhalwe by die Arbeidshof ingedien en wag vir afhandeling.

In 2018, SAOU (Limpopo) launched a second court case regarding the non-payment of hostel allowance. It included all members who received no or only partial payments between 2012 and 2017. The original application listed 32 SAOU members who indicated and proved that they were prejudiced. During the course of 2018, several of these listed members received payments before the case served in the Labour Court. Unfortunately, there are still 8 members who were not compensated, and the application has therefore been submitted to the Labour Court and is awaiting completion.
