Aanvraag van Benoemings

Om erkenning te gee aan SAOU lede se uitnemendheid, het die SAOU se Nasionale Uitvoerende Raad besluit dat die SAOU weer tydens sy eerskomende Nasionale Kongres op 30 Junie 2017 toekennings aan lede, skole en Hoër Onderwysinstellings sal maak. Lede word uitgenooi om benoemings te maak aan die hand van die volgende algemene kriteria:

- 'n Persoon mag hom/haarself nomineer.
- Genomineerde kan in diens van die Departement van Basiese Onderwys of 'n skool se Beheerliggaam wees.
- Genomineerde moet 'n SAOU lid wees.
- Wenner van die 2014 SAOU Kongres toekennings mag nie weer vir dieselfde toekenning genomineer word nie.
- Die genomineerde moes in die tydperk tussen die vorige Kongres en die komende Kongres in diens gewees het, sowel as 'n SAOU lid gewees het.
- 'n Benoeming word gemaak aan die hand van 'n volledige skriftelike motivering. Geen onderhoude sal met kandidate gevoer word nie.
- Die skriftelike motivering moet vergesel wees van:
 - Nominasievorm
 - 'n Onlangse kleurfoto (Jpg formaat – kop en skouers)
 - Gesertifiseerde afskrif van SARO registrasie

Call for Nominations

To acknowledge excellent performance, the SAOU's National Executive Council has decided to make awards to members, schools and Higher Education Institutes during the forthcoming SAOU National Congress on 30 June 2017. Members are invited to make nominations on the basis of the following criteria:

- A person may nominate him/herself.
- A nominee must be employed by either the Department of Education or a School Governing Body.
- A nominee must be an SAOU member.
- Winners of the 2014 SAOU Congress Awards may not be nominated again for the same award.
- The nominee must have been in service between the last Congress and the upcoming Congress, and a SAOU member.
- Nominations will be made in the form of a written motivation. Candidates will not be interviewed.
- The written motivation must be accompanied by:
 - Nomination form
 - A recent colour photo (Jpg format – head and shoulders)
 - A certified copy of SACE registration
