POSTEVOORSIENING 2017, PERMANENTMAKING VAN TYDELIKE OPVOEDERS EN BEVORDERINGSVAKATURELYS

Voortspruitend vanuit 'n vergadering met MDO op Woensdag, 19 Oktober 2016 bring die SAOU (Mpumalanga) die volgende belangrike sake onder die aandag van SAOU-lede.

- **PPN VIR 2017**

Die postevoorsieningskale vir 2017 is goedgekeur na konsultasies tussen die vakbonde en MDO. Die postevoorsiening vir skoolgebaseerde poste gaan dieselfde bly as vir 2016. Daar gaan dus geen poste gesny word vir 2017 nie.

MDO het onderneem om die PPN-skale teen Vrydag, 21 Oktober te versprei aan die Distrikskantore, waarna dit versprei sal word aan die skole. Skoolhoofde word versoek om via die lynfunksie navrae rakende die aangeleentheid te rig.

- **PERMANENTMAKING VAN TYDELIKE OPVOEDERS**

MDO is steeds van voorneme om in November te begin met die permanentmaking van die tydelike opvoeders. Skole sal binnekort in kennis gestel word watter tydelike opvoeders sal kwalifiseer

POST PROVISIONING 2017, PERMANENT APPOINTMENT OF TEMPORARY EDUCATORS AND PROMOTIONAL POSTS VACANCY LIST

Emanating from a meeting with MDE on Wednesday, 19 October 2016, the SAOU (Mpumalanga) would like to bring the following urgent matters to the attention of SAOU-members.

- **PPN FOR 2017**

The post provisioning norms for 2017 have been approved at a meeting between the unions and MDE. The PPN for school based educators will be the same as for 2016. No posts shall therefore be cut from the PPN for 2017.

MDE indicated that the PPN will be distributed to the District offices by Friday, 21 October and then to the schools. Principals are requested to send enquires regarding this matter via the departmental line function.

- **PERMANENT APPOINTMENT OF TEMPORARY EDUCATORS**

MDE's intention is still to start with the permanent appointment of temporary educators in November. The lists of temporary educators who will qualify in terms
