SALARISAANPASSINGS

SALARY ADJUSTMENTS

’n Lewenskosteverhoging miv 1 April 2019 is deur die Staat as werkgever afgekondig op grond van SKBR Ooreenkoms 1 van 2018.

A cost of living adjustment has been announced by the State as employer w.e.f. 1 April 2019 on the basis of PSCBC Agreement 1 of 2018.

Die ooreenkoms maak voorsiening vir ’n lewenskoste salarisverhoging van 6.2% vir salariskerwe 1-98; 5.7% vir kerwe 99-159 en 5.2% vir kerwe 160-221. Onderstaande is ’n **konsep** van die 2019 salarisskaal synde die finale skaal nog deur DBO in ’n Gazette gepubliseer moet word.

The collective agreement provides for a cost-of-living adjustment of 6.2% for notches 1-98; 5.7% for notches 99-159 and 5.2% for notches 160-221. Here below is a **draft** of the expected 2019 salary scale. Please note that this is not the formal salary scale as the final scale will be published in a Gazette.
