### Algemene Inligtingsvergadering 14 Maart 2018

### General Information Meeting 14 March 2018

SAOU-lede, maar veral skoolhoofde, is na alle waarskynlikheid teen hierdie tyd bewus van die felle smeerveldtog teen die SAOU en senior ampsdraers. Die Nasionale Dagbestuur, bestaande uit die President en die nege Provinsiale Voorsitters, het opdrag gegee dat inligtingsvergaderings met Provinsiale Uitvoerende Rade en waar nodig algemene inligtingsvergaderings vir lede in alle provinsies gehou moet word. Tydens hierdie vergaderings is volledig terugvoering mbt die vele aantygings teen die SAOU en senior ampsdraers verleen. Hierdie inligtingsvergaderings op provinsiale vlak is bykans voltooi.

Die Dagbestuur het ook opdrag gegee dat 'n algemene inligtingsvergadering voor die aanvang van die Nasionale Uitvoerende Raad (NUR) (die hoogste gesag in die SAOU tussen Kongresse) gehou moet word. Daar is reëlins getref dat die SAOU se regsvertegenwoordiger en die ouditeur aanwesig sal wees en volledig op elkeen van die aantygings, en moontlik ook ander onsekerhede, verslag sal lewer. Die NUR sal na afloop van die vergadering besprekinge in oorweging neem en die gepaste besluite neem.

SAOU members, but especially school principals, are in all probability acutely aware of the serious smear campaign against the SAOU and its senior office bearers. The National Standing Committee, comprising the President and the nine Provincial Chairpersons, has instructed that information meetings must be held with the Provincial Executive Councils, and where necessary, general information meetings must be held. During these meetings detailed feedback was provided in regard to the numerous accusations against the SAOU and senior office bearers. These provincial information meetings will be completed during this week.

The Standing Committee also instructed that a general information meeting must be held prior to the commencement of the National Executive Council (NEC) (the highest authority between Congresses). During this meeting the SAOU's legal representative and auditor will be present to deal with each of the accusations, as well as other enquiries. After the information meeting the NEC will consider the discussions and take the appropriate decisions.
