**PUR VERKIESINGSINLIGTING | PEC ELECTION INFORMATION
2019**

- Die **SAOU Vrystaat** is om organisatoriese redes in **vyf kringe** verdeel.
- Indien u onseker is in watter SAOU-kring u is, **sien ingeslote lys**.

- The **SAOU Free State** is divided into **five circuits** for organisational reasons.
- Please consult the **attached list** if you are uncertain about the circuit you are situated in.

SAOU VRYSTAAT KRINGINDELING

- **Neem Kennis:** A.g.v. bepalings binne SAOU Grondwet is SAOU Vrystaat slegs geregtig tot 5 kringe. Maak baie seker dat die persoon wat u nomineer wel in die korrekte SAOU kring val, alvorens u aan enige nominasie of stemming deelneem.
- Uit elke kring moet **3 kringorganiseerders** verkies word en die **verkose lede** vorm dan deel van die Provinsiale Uitvoerende Raad (**PUR**).
- Wanneer lede dus nominasies maak, moet die vereistes van die SAOU Grondwet in gedagte gehou word.

Volg dié skakel: (SAOU Grondwet)

Daarvolgens word verlang dat jonger persone, mans en dames, alle rasse, gestremdes verteenwoordig word.

- Elke lid mag 'n maksimum van **drie lede** uit dié Kring as Kringorganiseerders nomineer.

SAOU FREE STATE CIRCUIT DIVISION

- **Take Note:** In terms of the SAOU Constitution is SAOU Free State divided into 5 Circuits. Make sure that the person you nominate is indeed in the correct SAOU circuit before you participate in any nomination or voting process.
- Within each circuit, **3 circuit organisers** should be elected and these **elected members** form part of the Provincial Executive Council (**PEC**).
- When members nominate a person the requirements of the Constitution must be considered.

According to the Constitution younger members, men, women, all races and people with a disability should also be represented.

- Each member may nominate a maximum of **three members** in their circuit as a Circuit organiser.

NOTA: Indien *slegs drie persone* uit 'n bepaalde kring genomineer word, sal hulle as wettig verkose beskou word.

- 'n Aparte nominasievorm moet vir elke genomineerde voltooi word.
- Die genomineerde sal sy / haar toestemming moet verleen. 'n Ondernemingsvorm sal aan u gestuur word en moet aan elke genomineerde verskaf word. Inligting daarop sal ook as CV dien.
- Lede sal op **19 September 2019** per **SAOU Verkiesingsnuusbriëf 2** ingelig word rakende die nominasie- en verkiesingsproses, asook die sperdatums verbonde aan beide prosesse.

BETROKKENHEID VAN SAOU-LEDE:

Alle prosesse, uitslagvorme en relevante verkiesingsdokumentasie sal geverifieer en bekragtig word deur twee onafhanklike Ouditeursfirmas. Die besonderhede van die genoemde ouditeursfirmas kan bekom word via die Provinsiale Sekretaris.

Alle SAOU-lede moet betrokke wees by hierdie belangrike prosesse in die funksionering van die SAOU en moet nou reeds begin met die identifisering van lede wat hulle as hulle leiers in die verskillende posisies wil laat verkies.

Die persone wat u as leiers verkies, is die persone wat u belange by die tersaaklike strukture gaan verteenwoordig.

NOTE: If *only three people* from a particular circuit are nominated, they will legally be considered as the elected members.

- A separate nomination form must be completed for each nominee.
- The nominee must give his / her consent. A commitment form will be forwarded to you and must be provided to each nominee. Information therein will also serve as a CV.
- Members will be informed on **19 September 2019** via **SAOU Elections Newsletter 2** on the nomination-, election process and the due dates involved in both processes.

INVOLVEMENT OF SAOU MEMBERS:

All processes, outcome reports and relevant election documentation will be verified and validated by two independent audit firms. The details of the said Audit Firms can be obtained via the Provincial Secretary.

All SAOU members should participate in these important processes and in the functioning of the SAOU. Identify members as SAOU's elected leaders in the different positions.

The members you elect as leaders will be the leaders that will represent your interests in the relevant structures.
